Additional information

Because the EUT has no immunity related functions, Radiated immunity and Bulk current injection tests are not applicable and therefore not performed.

The Voltage transient emissions measurements and the Electrical Disturbance test on Voltage supply lines are not performed because the EUT is a derivative type of the Mass Combi Ultra (24/3500), which is tested worst case and reported under DARE!! Measurements reference number 18C00036RPT01. See appendixes E and F of reports 17C01308RPT01 and 18C00036RPT01.

The charger function is not tested during this test session because the charging function is not operational in driving mode, does not charge the vehicle battery and also is not connected to the vehicle battery.
