

his light utilizes a 50 watt HID xenon lamp and 50 watt ballast. It is the only underwater light with a built in igniter and ballast in the actual body of the casing. It is the brightest 12 or 24 volt DC light available. It can be installed on small to mid size boats including center console, sportfishers and cruisers. The vessel must be hauled out for installation although lamp change and any maintenance can be done in the water from within the hull.

Introduction:

Congratulations on the purchase of your new thru hull light (Patent No. US 7,458,330 B2). Underwater Lights® USA, LLC takes pride in providing well designed, high quality and thoroughly tested lights that allow you to "enhance your boating experience". These lights can be installed in your vessel for aesthetics, to attract fish, for security and safety.

General Operating Information:

The 50W, HID, gas discharge lamp used in this light is a commercial grade high technology instant re-strike lamp. This lamp will generally reach full brightness in less than 1 minute.

The light can be operated for a brief period of time when the vessel is out of the water, but, it is crucial that the vessel is in the water to ensure proper lamp cooling, however, the light can be operated while the vessel is underway.

Depending upon water clarity conditions, the light beam can reach up to 21 meters (70 feet).

General Safety Information:

This light is intended for use on fiberglass and wood hulled vessels.

Never try to install or remove this light while the vessel is in the water.

The body of the light must be electrically joined to the vessels grounding and cathodic protection system. Failure to do so may cause light corrosion.

Always disconnect and lock-out power before working on light.

The light should be visually inspected every six months.

The light and electrical cabling should be visually inspected for proper operating condition every six months.

Marine growth should be removed from the glass using a soft brush to allow both heat and illumination to exit the light.

Caution! Because reversing polarity will severely damage the Ignitor with Ballast, RED wire must be connected to (+) POSITIVE, BLACK wire must be connected to (-) NEGATIVE and RED wire mounted fast blow fuse must be used.

Installation:

This light should be installed at least 250-300mm (10-12") below the water line by qualified/approved personnel using proper tools and materials. The minimum hull thickness is 12mm (0.47") and maximum is 107mm (4.2") with an access area of at least 115mm (4.5") left behind the light for lamp servicing and general ventilation.

After selecting a flat surface, cut a 80mm (3-1/4") diameter hole through the vessel hull in the desired location. Caution! Check that no electrical wiring, fuel lines, oil lines, water lines etc., pass near or through the intended hole location.

Remove numbers (7), (6), (8), (9), (16) + (5) from the light. Carefully coat the Main Body (1), Front Flange (2) and inner surface of above cut hole with 3M 5200 Marine Adhesive or equivalent. Caution! Avoid placing adhesive on main body threads. Note: Exposed inner hole surface must be properly sealed before light installation to prevent potential water intrusion into the hull proper.

Holding the Front Flange (2), push the light through the hole, slide the Compression Ring (6) over the Main Body (1) and then tighten the Locking Ring (7) hand tight. Note: Ensure that the tips of all three fasteners (18) are NOT touching the Compression ring (6). After the 3M 5200 Marine Adhesive is fully cured, tighten the three fasteners (18) to 9 Nm (7 ft/bs) using a 5mm allen wrench.

Slip the Reflector Tube (5) and Ignitor with Ballast (16) into the Main Body (1), place the Projector Cap (9) over the end of the Main Body (1) and then screw the Projector Lid (8) onto the Main Body (1) hand tight. Connect the RED wire lead to a switched and fused 12VDC power source (using supplied fast blow fuse) and the BLACK wire lead to good ground. Caution! Reversing polarity will severely damage the Ignitor with Ballast.

Upon completing light installation, it is highly recommended that Front Flange (2) be coated with antifouling paint. Also, hand tighten 4mm set screw located in Locking Ring (7), then connect wire lead from 4mm screw provided on Locking Ring (7) to the vessels grounding and cathodic protection system.

Serviceable Parts:

Lamp replacement is done by unscrewing the Projector Lid (8), removing the Projector Cap (9), sliding the Ignitor with Ballast (16) out of the Main Body (1) and removing the Lamp (15). Light re-assembly by is done by reversing said procedure. Caution! Ensure that the new lamp is clean and free of dust, dirt, grease, oil, water and finger prints. Additionally, Glass (10) and Glass Gasket (11) replacement is not field serviceable on this light.
